

## REPORT BY THE BOARD OF DIRECTORS PURSUANT TO THE DANISH COMPANIES ACT 156(2)(2)

The Board of Directors has proposed to cancel some of the acquired treasury shares resulting in the share capital being reduced by treasury shares of a nominal value of DKK 6,526,507 allocated to 6,526,507 own shares with a nominal value of DKK 1. The reduction of the share capital is in accordance with the Danish Company Act section 188.
